## **Criteria**

Nominee must be a committed union member who is an activist and leader in her union, community or beyond, who is dedicated to equity and labour activism. Nominations must include the completed nomination form and a detailed profile of the nominee, describing her contribution to the labour movement and the advancement of women's rights. Current members of the NSFL Women's Committee are ineligible for this award.

The NSFL Sister of the Year Award celebrates a union sister who has proven their dedication to the trade union movement and the advancement of women's voices. The Sister of the Year is a woman who works tirelessly and deserves to be recognized for her hard work and dedication. This award is aimed at grass roots labour and women's rights defenders. It acknowledges that women contribute in a variety of ways. When women raise their voices, they also raise the voices of the women around them, offering strength and encouragement.
